#### Description

1. The Pandi Water District, through the Capital Expenditures intends to apply the sum of Two million ninety-two thousand nine hundred seventy-two and sixty centavos (PHP 2,092,972.60) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery and Installation 15HP Pump Set, Ø 100mm Discharge Piping and 50 KVA (1-Phase) Generator Set at Pandi Residences Home I, Brgy. Mapulang Lupa, Pandi, Bulacan / 21-10-04. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Pandi Water District now invites bids for Supply, Delivery and Installation 15HP Pump Set, Ø 100mm Discharge Piping and 50 KVA (1-Phase) Generator Set at Pandi Residences Home I, Brgy. Mapulang Lupa, Pandi, Bulacan / 21-10-04. Completion of the Works in required thirty calendar days (30c). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, Particularly, in Section II, Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Pandi Water District and inspect the Bidding Documents at the address given below during 8 a.m. to 3 p.m. or visit our website.

5. A complete set of Bidding Documents may be acquired by interested Bidders on October 7 to October 14, 2021 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five thousand pesos only (PHP 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Pandi Water District will hold a Pre-Bid Conference on October 13, 2021 / 2:00 p.m. at 2nd Floor Pandi Water District Building, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before October 27, 2021 1:00 p.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on October 27, 2020, 2:00 p.m. at 2nd Floor Pandi Water District Building. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Pandi Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
