- 6. The Citizen's Charter is also published in a brochure-type information material and distributed to the concessionaires of Pandi Water District.
- 7. The Citizen's Charter was first published on 2009 and undergoes continuous review and revisions as required under Section 4, Rule IV of the IRR, which provides for a review of the Citizen's Charter whenever necessary, but not less than once every two years.
